MISSION OF PUBLIC SAFETY

The mission of the Carver College Police Department is to provide a safe environment for the Carver College community through education and crime prevention awareness programs, by promoting an atmosphere of security in and around the campus, and supporting a culturally diverse atmosphere for all employees, students, and visitors. This mission would not be complete without the full support of Carver College. The Carver College Police Department works closely with other College Departments, including Office of the President, Vice President of Student Affairs, and the Vice President of Finance.

YOUR SECURITY AT CARVER COLLEGE

Your safety and security is extremely important to us at Carver College. The following information is provided to share our commitment to the security of our College family, to inform you about our campus security policies and procedures and to let you know how to report crime or suspicious behavior and the steps you can take to assist the Police Department in keeping the College Community safe.

PUBLIC SAFETY ON CAMPUS

The Police Department patrols the campus on a part-time basis, 7 days a week. The Department is responsible for the security of the Carver College campus and a variety of off- campus housing locations. The Police Department consists of a Chief of Police, 2 Captains, 2 Lieutenants, 2 Sergeants, 4 Corporals, and 9 part-time Police and Auxiliary officers. Police officers are P.O.S.T. Certified officers in good standing and Auxiliary officers augment public safety by assisting in educating the campus community on security concerns and enforcing College policies.

DAILY LOG

In compliance with the Clery Act, the Carver College Police Department maintains a daily log of reported crimes. All crimes reported to the Public Safety Department are documented in a daily Crime log. The Crime log records information of alleged criminal incidents reported to the Police Department – the nature of the crime, its general location, the date reported, the date and time occurred and the disposition of the complaint. The daily Crime log is in the Police Department.

EMERGENCY NOTIFICATION SYSTEM

If a significant emergency or dangerous situation involving an immediate threat to the health or safety of students or employees occurs on campus, the College will employ its emergency notification system. Once it is determined that there is a significant emergency or immediate threat, the College shall issue the notification without delay. The College will follow its Emergency Response Plan (see section titled Emergency/Response Plan). A timely warning need not be issued if an emergency notification has been issued based on the same circumstances.

If a situation arises, either on or off campus, that, in the judgment of the Chief of Police, constitutes an ongoing or continuing threat to the campus community, a campus wide “timely warning” will be issued. The “timely warning” alerts the campus and aids in the prevention of crime. The warning will be issued through the College notification system. The Police Department may also provide the College community with more immediate notification. In such instances, warnings disseminated through the College e- mail system and/or posted to the website will describe the nature of the event and/or a copy of the notice is posted in each residence hall or the front door for each apartment or other buildings which may be affected by the criminal threat.

CRIME RATES AND STATISTICS
